Gained one (1) year of QS experience and graduate of PICQS Academic Partner (MoU with PICQS).

Member to initiate the request by filling out the Membership Progression Request Form and attachments of the proof of compliance to requirements.

Member is entitled to use post nominal: **TPICQS** and must clearly state as **Technical Member of PICQS**. Membership shall expire at the end of each calendar year and subject to PICQS GMC's renewal validation.



ASSOCIATE MEMBER

NON-CORPORATE LEVEL MEMBERSHIP CATEGORY

- Route 1 – Gained five (5) years of QS experience and with Accredited QS Study of at least 500 hours.
- Route 2a – Gained ten (10) years of QS experience under approved supervision and [Qualification](#).
- Route 2b – Gained fifteen (15) years of QS experience without approved supervision and [Qualification](#).
- Route 3 – Completed PICQS P3T, PAP1 and GaMP.
- Route 4 – PICQS APC registered.
- Route 5 – Obtained membership of QS Professional Body recognised by PICQS (Associate RICS, Affiliate Member of NZIQS, CIQS CCE)

Qualification:

- a. *Has served Management Board for at least 2 consecutive years or*
- b. *A Subject Matter Expert delivering one of PICQS' external programs for at least three (3) consecutive sessions*

Except for Route 3 and 4, Member to initiate the request by filling out the Membership Progression Request Form and attachments of the proof of compliance to requirements.

Member is entitled to use post nominal: **APICQS** and must clearly state as **Associate Member of PICQS**.
Membership shall expire at the end of each calendar year and subject to PICQS GMC's renewal validation.

- Route 1 – Candidate with Accredited Degree / Formal Education in Quantity Surveying
- Route 2 – Candidate with Bachelor's Degree in Engineering
- Route 3 – Candidate with Other Educational Qualification
- Route 4 – Senior Management Role experience / Academic Experience
- Route 5 – Membership Holder of QS Professional Bodies with agreement with PICQS (achieved MRICS, MAIQS, MNZIQS, CIQS PQS)

*Progression to PICQS Corporate Member Grade must go through the routes applicable in accordance with the **PICQS Assessment of Professional Competence (APC)**.*

GMC will automatically record and update in the database, upon receipt of the APC Final Assessment Result confirmation from PICQS Global APC Committee.

Member is entitled to use post nominal: **MPICQS** and must clearly state as **Corporate Member of PICQS**. Membership shall expire at the end of each calendar year and subject to PICQS GMC's renewal validation.
